



# My dear Confreres,

Paschal Mystery of Jesus Christ. Immersed as we are in the spiritual atmosphere of the Holy Week, we commemorate the central events of our salvation and the essential core of our Christian faith -- the Passion, Death and Resurrection of Jesus Christ -- over Maundy Thursday, Good Friday, and Holy Saturday with the Easter Vigil. The liturgical build-up to the Triduum is with a reminder of the double betrayal of Judas and Peter as well as the collective failure of the disciples in order to underline the fact that acceptance and the love of Jesus far exceed the failure of the disciples.

On Maundy Thursday we commemorate that evening when Christ left his disciples the testament of his love in the Eucharist as his everlasting presence. Both the pouring of the water at the washing of the feet as well as the wine in the chalice – core symbolisms of Maundy Thursday -- remind us of the blood poured out at his death. Feet too are symbolically very significant. On the one hand, they are that part of the body that gets dirty fastest. On the other

hand, feet carry the whole body around. We go where the feet take us. If our feet follow Jesus, then it is us who follow Jesus. Besides, Maundy Thursday speaks in a special way to us who are priests; it speaks of Christ "who makes us sharers in his priesthood, in his 'anointing' through our own priestly ordination," anointed to be another priest-victim like him.

We all will gather on Good Friday as though we were on Calvary to commemorate the redemptive Passion and Death of Jesus Christ, and while adoring the Cross, we will relive the journey of the innocent Lamb sacrificed for our salvation. We who participate in his passion through our service today are called not just to endure our own crosses, not to put-up with the cross, but rather to *'embrace'* the cross. Thereby, we will carry in our minds and hearts the sufferings of the sick, the poor, the rejected of this world and bring in prayer "sacrificed lambs" in our time.

To a world that expects dead things to stay dead, broken hearts to stay broken, Easter comes with new life, with grace, with healing, and with resurrection. "When Jesus speaks about eternal life, he is referring to real and true life, a life worthy of being lived. He is not simply speaking about life after death. He is talking about authentic life, a life fully alive and thus not subject to death, yet one which can already, and indeed must, begin in this world. Only if we learn even now how to live authentically, if we learn how to live the life which death cannot take away, does the promise of eternity become meaningful." (Pope Benedict XVI) May the saving power of Christ's resurrection fill all of us so that we can overcome every expression of that "culture of death" with which we get increasingly surrounded.

# **INTERNAL AUDITING OF THE PROVINCE**

O ur internal audit team has been going around our communities and institutions and doing a commendable job. In several cases, due to lack of sufficient familiarity with the nuances of account keeping, some issues have cropped up. As you are all well aware of the fact that the income tax department has in recent times tweaked changes to the requirements of accounting by charitable institutions and are meticulously monitoring the compliance of them. Any failure on our part can lead to very severe consequences like cancellation of the FCRA Accounts and the like, which has already been done in some cases. In order to insulate ourselves from any drawbacks from our part and to ensure that we do our accounting meticulously as per the requirements, **the following guidelines are made mandatory for all who are dealing with financial administration in our province**:

- 1. Please maintain Day Book whereby all the transactions of the day, both the income and the expenses, are recorded.
- 2. Please maintain a separate Cash Book whereby cash receipts & payments are recorded. Daily transactions of cash receipt and payments must be updated. If it is maintained in the computer system in excel, print and file the same on a monthly basis.
- 3. Accounts must be updated on a daily basis (not on annual, once in six months, monthly or even weekly basis).
- 4. As the accounts are written, keep the respective supporting bills, invoices and documents with the voucher and also the receipt books.
- 5. Obtain all the invoices & bills at the time of payment itself, so that the accountant can avoid booking entries under suspense and go behind them to clear it whereby a lot of time can be saved.
- 6. All the bills must have a covering voucher which will have details of "to whom" and "for what" it is paid. It would be better if the person incurring the expense write the voucher as he is aware of what that expense is for.
- 7. Present the monthly Receipts & Payments Account in the monthly Community meeting.
- 8. Submit the current monthly accounts to the Head Office by the 10<sup>th</sup> of next month.
- 9. Institutions where accounts are entered in Tally at a common place, submit a copy of the excel statement / day book on a weekly basis through mail so that if any TDS compliances are required, it could be attended to. So that TDS remittance can happen by 7<sup>th</sup> of next month without any interest or penalty.
- 10. If any kind of donations are received by the institution / community, kindly obtain the PAN and complete address of the donor irrespective of the amount.

Please note that from this financial year onwards, the province accountants will not be visiting different centres to collect accounts, instead submit bimonthly your accounts to the respective Province accountant of your house/ institution with all details of income and expenses.


